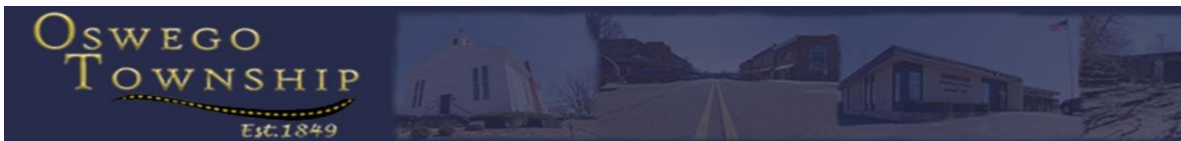


**PUBLIC NOTICE**
